All of our manufacturing sites are certified to ISO 15378 standards. Our staff are fully committed to consistently adhering to GMPs and applicable regulations to ensure we deliver the level of quality demanded by the Pharmaceutical industry. SGD Pharma collaborates with its clients to design quality specifications that meet their needs.

Quality control throughout the manufacturing process

SGD Pharma controls and manages each step of the entire production process through the following controls and tests:

- \cdot Fully automated inspection systems from the initial composition of raw material to the final packing
- · 100% on-line inspection to verify the vials to dimensional, functional and visual
- · Physicochemical testing according to pharmacopoeias (USP, EP, CFDA, JP)
- · Batch release based on complete manufacturing records and QC results

Production and control records are maintained in a computerized system that ensures full traceability.

Regulatory support

Primary packaging, in particular for parenteral drugs, needs to comply with the strictest standards and regulations, as it contributes to the stability and quality of the drug products. SGD Pharma provides Pharma and Biotech companies with all the necessary documentation to simplify the registration and approval processes of their products with the Regulatory agencies.

Pharma Grade Glass

All SGD Pharma facilities are equipped with ISO 8 clean rooms. Particulate levels are strictly and regularly monitored. On-line inspection and packing are performed in this clean environment to deliver compliant vials for patient safety.

Our clean rooms include air locks for controlled material and personnel flow. All staff are highly trained in clean operations, proper gowning and meeting GMP regulations.


